THE UNDERSIGNED, for itself, its heirs, administrators, executors, assigns, its predecessors, successors, subsidiaries, affiliates and any other person claiming thereunder, does in consideration of permission to exhibit and distribute any food and beverages, whatsoever, within the METRO TORONTO CONVENTION CENTRE and of the mutual convenants herein and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged does hereby remise, release and forever discharge METRO TORONTO CONVENTION CENTRE CORPORATION, its predecessors. successors, subsidiaries, affiliates, assigns and the current and former agents, officers, directors and employees of all of them from and against any and all manner of claims, actions, causes of action, suits, proceedings, covenants, liabilities, obligations, demands, rights and debts, sums of money, duties, dues, accounts, interest, bonds, convenants, contracts, claims for damages whatsoever which the undersigned ever had, now has, can, shall or may hereafter have against for or by reason of any cause, matter or thing arising out of or in connection with its exhibit and/or distribution of food and beverages whatsoever with the METRO TORONTO CONVENTION CENTRE.

THE UNDERSIGNED for the said consideration acknowledges, declares and agrees that it fully understands the terms of this general release and that it voluntarily accepts the general release.

THE UNDERSIGNED understands and agrees that in the event that it should hereafter make any claim or demand or commence or threaten to commence any action against the METRO TORONTO CONVENTION CENTRE CORPORATION for or by reason of any cause, matter or thing, this document may be raised as an estoppel to any claim, demand or action commenced in regard to the aforesaid.

THE UNDERSIGNED hereby undertakes to execute and deliver to METRO TORONTO CONVENTION CENTRE CORPORATION at the request and expense of METRO TORONTO CONVENTION CENTRE CORPORATION such further and other documents or instruments as may be reasonably required from time to time to further effect this RELEASE.

THE UNDERSIGNED hereby undertakes to execute and deliver to METRO TORONTO CONVENTION CENTRE shall be manufactured, processed, prepared, stored, handled, displayed, distributed, transported, sold and offered for sale in accordance with all municipal, provincial and federal statutory health and safety legislation and regulation.
